# PRESIDENT'S MESSAGE

The dog days of summer. This phrase evokes images of long, hot days and a slower pace to life. However, as BetterInvestors we know that the financial markets do not necessarily fit this profile. In June 2024, the S&P 500 rose 3.47%, bringing its YTD return to 14.48%. The Dow Jones Industrial Average hit a new high, crossing 40,000 points for the first time in July 2024. Finally, the Nasdaq Composite reached a new high of 18,647 on July 10th and has a YTD return of 23.63%.

The Chicagoland chapter directors have also been busy this summer. This pace began in May with the **2024 BetterInvesting National Convention (BINC) in Chicago** held at the Marriott O'Hare Hotel. The chapter was involved in convention planning, authoring an article for *BetterInvesting* magazine and having two instructors teach at the event. I was encouraged by the substantial number of attendees at the convention but equally as important, the representation of young people participating in BINC. Attendees were eager to learn the latest in investing and mingle with old friends and new acquaintances, talking stocks and comparing notes.

This energy carried over in June during the chapter's **annual planning meeting**. This planning meeting takes place during the summer months to strategize activities for the BI fiscal year 2024-25, line up speakers and determine education sessions, as well as set goals for member communications and club visits. Ideas for the upcoming year including:

- A return of 1-2 in-person classes. We will continue to offer online education given the geographic reach of the chapter.
- Add more presenters to the popular Stock Discussion Group to assist Paul Rom and add different points of view.
- All directors submit First Cuts for publication in *BI Weekly*.
- Schedule a national speaker to our educational calendar.
- Investigate community calendars or church notices where BI might participate in local programs.
- Hold a meet and greet where members can talk to chapter directors.




## 2024 BINC in Chicago – Learning, Networking and Excitement

With over 60 education sessions on several investment topics and opportunities to network with fellow attendees, BINC in Chicago provided something for everyone.

BINC kicked off with a surprise. Deane Jaeger, 2024 BINC Chair, provided welcoming remarks and asked all veterans in the audience to assist in BINC's opening ceremonies by asking them to join him on stage.
